

PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Subject: Sanction of affiliation for establishment of Revana Siddeshwara Institute of Technology, Chokkenahalli, Devanahalli Taluk, from the academic year 1997-98.

- Read: 1) D.O.Letter No. ED 55 URC 97 dated 28-4-97
2) Letter No.F.770/53/230/ET/97 dated 29-8-97 of the AICTE, New Delhi.
3) Letter No.ACA.3/SAPASA/HOKAPRA/97-98 dt. 3-6-97 of the Registrar, Bangalore University.

PREAMBLE:

1) Under Section 10(k) of the AICTE Act, 1987, read with AICTE (Grant of approval for starting new Technical Institutions, introduction of courses or programmes and approval of intake capacity of seats for the courses or programmes) Regulations, 1994, prior approval of the AICTE shall be obtained for establishment of new Engineering Colleges. Under Regulation 7 of the said Regulations, 1994, every application for the approval of AICTE shall be submitted to directly AICTE before 31st December of each year under copy to (1) State Government (2) Bureau of the Regional Committee of the Council and (3) The concerned University. Under Regulation 8, the State Government, inter-alia, shall offer its comments/recommendations on the applications so received by it within the time frame prescribed in the schedule appended to the said Regulations. Accordingly, State Government had conveyed its comments/views/recommendations to the AICTE after due consideration of all the aspects governing establishment of new Engineering Colleges in the State of Karnataka in the D.O.Letter dated 28-4-97 including the case of Revana Siddeshwara Institute of Technology, at Chokkenahalli run by Revana Siddeshwara Education Trust, Sanganagar, Bangalore, invoking the said Regulation 8 for sanction of approval to establish an Engineering College under Section 10(k) ibid effective from the academic year 1997-98.

2) In the meantime, the above college had also applied to Bangalore University seeking affiliation under Sec.52 of the KU Act, 1976. The report of the LIC, AC and the Syndicate were considered as required under Sec.53(5) ibid.

3) In its letter dated 4-8-97 the AICTE, New Delhi, has approved under Sec.10(k) ibid the above college effective from academic session 1997-98 subject to compliance of norms and standards prescribed by the AICTE.

4) In view of the specific approval of the AICTE to the above College and in the light of the proposal so received from the University for sanction of affiliation, it is considered necessary to sanction the above Engineering College and recommend grant of affiliation to Revana Siddeshwara Institute of Technology, Chokkenahalli, Devanahalli Taluk.

5) In exercise of the powers conferred under Sec.53(5) of the K.S.U. Act, 1976, the Government of Karnataka recommends the sanction of affiliation to Revana Siddeshwara Institute of Technology, Chokkenahalli, by Bangalore University, effective from the current academic year 1997-98, with the following courses of study and intake specified against

each, run by Revana Siddeshwara Education Trust.



1.	MECHANICAL ENGINEERING	SIXTY (60)
2.	ELECTRONICS & COMMUNICATION ENGINEERING	SIXTY (60)
3.	COMPUTER SCIENCE & ENGINEERING	SIXTY (60)

6) Sanction of affiliation shall be subject to the following conditions:-

- (1) The management of the College shall not seek any financial assistance in the nature of Grant-in-Aid from Government of Karnataka for running the college or any courses of study therein. The College shall be subject to no-grant for ever basis. The management shall execute an interim undertaking to that effect.
- (2) The College shall not infringe/contravene or violate the norms and the standards prescribed by the AICTE, the conditions laid down by the Government from time to time, the statutes, regulations and the ordinances enacted by the University regulating courses of study in Engineering/Architecture from time to time.
- (3) Admission of students shall be strictly in conformity with the Karnataka Selection of Candidates for Admission to Engineering, Medical, and Dental Courses Rules, 1997, as amended from time to time and the orders issued by Government, University and Director of Technical Education from time to time.
- (4) The fee chargeable in respect of the students shall be as prescribed by Government from time to time.

7) Government reserves its liberty to withdraw the affiliation if the College fails to fulfil any of the conditions adverted to hereinabove or issued by Government, University, AICTE and the Director of Technical Education from time to time.
